By the execution hereof, I hereby RELEASE and HOLD Miss Rodeo Oregon Inc. Foundation, and the Miss Rodeo Oregon Pageant, the officers, directors, accredited sponsors both commercial and private, employees, agents, members, volunteer, and/or representatives of each, HARMLESS from any and all rights, claims and/or actions, direct and/or indirect, fixed and/or contingent, of whatsoever kind and/or character, as shall now exist and/or hereafter arise from, and/or be the result of, my, and/or persons related to, my Sweetheart's appearance and/or participation in the Miss Rodeo Oregon Pageant, its programs, activities and/or functions.

The undersigned does acknowledge that they are familiar with equestrian and rodeo sports and activities and that the same are inherently dangerous to herself and those related to her participation therein. The undersigned further acknowledges that the Miss Rodeo Oregon Inc. Foundation and the Miss Rodeo Oregon Sweetheart Pageant cannot and does not guarantee the safety or well being of any participant does not guarantee against harm to the participant, does not guarantee the conduct of any participant other than the undersigned. The undersigned acknowledges that this release and indemnification is executed without specific knowledge of existing or future rights, claims, or actions, but executes the same notwithstanding such lack of knowledge, the risk thereof being known by, and assumed by, the undersigned and found to be reasonable for her assumption.

By the execution hereof, the undersigned does:

- Grant permission to the Miss Rodeo Oregon Inc. Foundation and the Miss Rodeo Oregon Sweetheart Pageant to verify any and all information contained herein by and through information held by persons other than the undersigned and shall execute and

deliver to the above named entities such documents as are required to obtain any and all information reasonably necessary to verify any and all such information.

- Certify the participant to be the appropriate age as evidenced by the Certificate of Birth attached.
- Because of the non-competitive nature, a Miss Rodeo Oregon Sweetheart is not required to make any appearances after the conclusion of the Sweetheart Pageant. A Sweetheart may enter the Sweetheart Pageant as many years as she is eligible, should she desire.
- Sweethearts can participate in events in her local community and other rodeo events from the conclusion of the Sweetheart Pageant until the beginning of the pageant the following year (unless she reenters).
- The Sweethearts appearing at events and representing their title are required to be dressed appropriately in clean attire. This includes wearing her crown on a western hat, western shirt tucked into jeans and sash or rodeo queen appropriate formal dress.
- Sweethearts are not permitted to appear on horseback at any event, including parades, unless specifically approved prior to the event in writing by the Sweetheart Liaison.
- Miss Rodeo Oregon Sweetheart is NOT allowed to engage in any fund raising activities for herself (i.e. coronation), solicit for sponsors and/or donations and cannot advertise herself or the program without consent of the Miss Rodeo Oregon Inc. Foundation.

The undersigned does agree that the foregoing certifications and agreements are continuing in nature, and if the undersigned shall fail to provide notice of the change in any of the above certifications and authorizations during her participation in the Miss Rodeo Oregon Sweetheart Pageant, she will automatically and without notice be disqualified from further participation in the Miss Rodeo Oregon Sweetheart Pageant, and does hereby agree to indemnify and hold the Miss Rodeo Oregon Sweetheart Pageant, the Miss Rodeo Oregon Inc. Foundation, together with the officers, directors, accredited sponsors both commercial and private, employees, agents, members, volunteers, or representatives of each, harmless as against all rights, claims and actions arising by reason thereof.

Applicant agrees and stipulates that disqualification from participation in the Miss Rodeo Oregon Sweetheart Pageant either before or after the competition will result in damages to the Miss Rodeo Oregon Inc. Foundation. In this regard, the applicant agrees to pay the Miss Rodeo Oregon Inc. Foundation a sum equal to all monies and consideration received as the result of applicant's participation in the Miss Rodeo Oregon Sweetheart Pageant, the same being declared liquidated damages as between the parties.

In the event the undersigned shall receive the title of Miss Rodeo Oregon Sweetheart, she and her parents/guardians agree to complete the tenure of title in accordance with the rules and

regulations of the Miss Rodeo Oregon Inc. Foundation; shall at all times act in the best interest of and to promote the Miss Rodeo Oregon Sweetheart Pageant; make such public appearances as shall be designated by the Miss Rodeo Oregon Inc. Foundation, without compensation for time and/or service.
